

**RESOLUTION FOR ADOPTION BY THE BOARD
OF EDUCATION OF NORTHVIEW PUBLIC SCHOOLS
2021-2022 GENERAL FUND BUDGET
ADOPTED: JUNE 28, 2021**

RESOLVED, that this resolution shall be the general appropriations of Northview Public Schools for the 2021-2022 fiscal year. A resolution to make appropriations; to provide for the expenditure of the appropriations; and to provide for the disposition of all income received by Northview Public Schools.

BE IT FURTHER RESOLVED, that the total revenues and unappropriated fund balance estimated to be available for appropriations in the General Fund of the Northview Public Schools for the 2021-2022 fiscal year are as follows:

BE IT FURTHER RESOLVED, that 18.0000 ad valorem mills shall be levied in 2021 on all non-homestead property for general operating purposes.

BE IT FURTHER RESOLVED, that .7069 ad valorem mills, as reduced by impact of the Headlee Amendment (Article 9, Section 31 of the Michigan Constitution), shall be levied in 2021 on all property for recreation purposes.

BE IT FURTHER RESOLVED, that no Board of Education member or employee of the school district shall expend any funds or obligate the expenditure of any funds except pursuant to appropriations made by the Board of Education and in keeping with the budgetary policy statement hitherto adopted by the Board. Changes in the amount appropriated by the Board shall require approval by the Board.

BE IT FURTHER RESOLVED, that the Superintendent is hereby charged with general supervision of the execution of the budget adopted by the Board and shall hold the building principals and department heads responsible for performance of their responsibilities within the amounts appropriated by the Board of Education and in keeping with the budgetary policy statement hitherto adopted by the Board.

BE IT FURTHER RESOLVED, that for purposes of meeting emergency needs of the school district, transfers of appropriations may be made upon the written authorization of the Superintendent. When the Superintendent makes a transfer of appropriations as permitted by this resolution, such transfer shall be presented to the Board of Education for consideration and adoption by the Board of Education.

This budget appropriation resolution shall be effective July 1, 2021.
